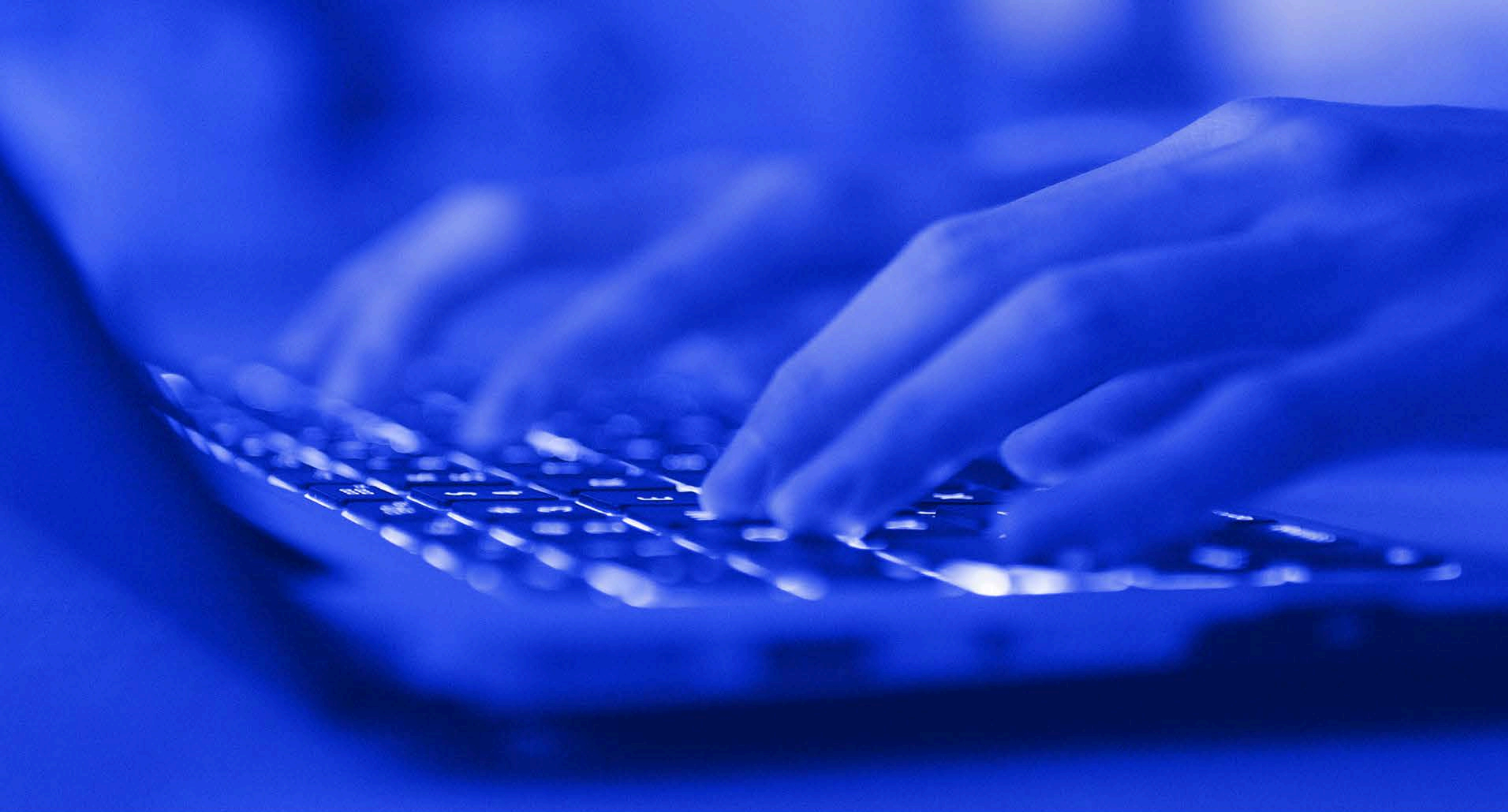

Our Process

Creating Your Base Digital Security Structure

- Requires only a single online appointment that typically takes about three hours.⁸
- Scheduled at your convenience, including at nights and on weekends.

Technology is installed on your devices, and you are taught how to use them.

Includes password manager, virtual private network (VPN) and a private email.

Other online accounts are added to your password manager in an online appointment.

Your properties are registered for title fraud notifications.

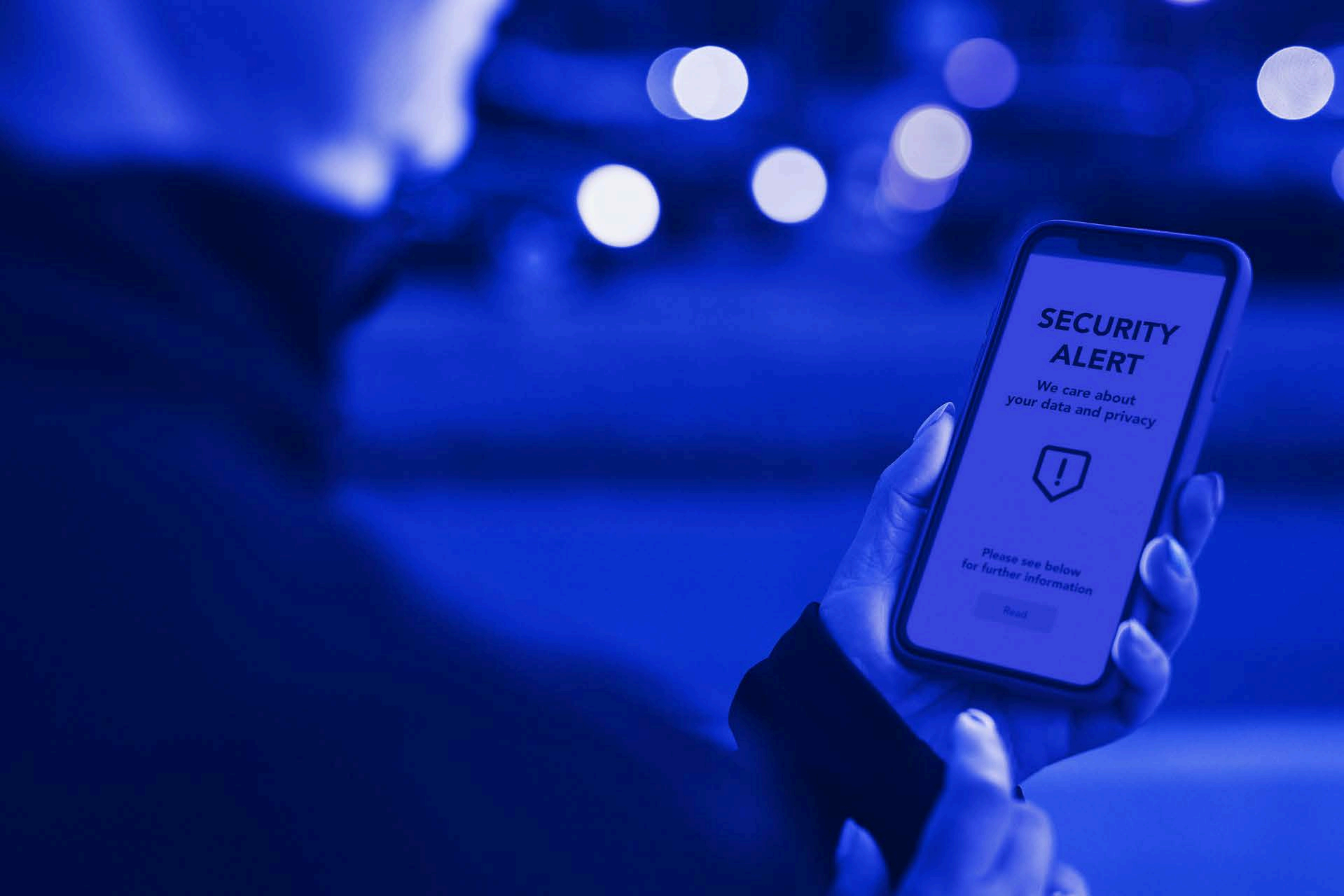
We also opt you out of pre-approved insurance and credit mailers.

 - Wipe lost and retired devices.
- Engage the privacy and security settings on new devices.
 - Alert you to new potential cyber threats.

Monitoring to See If You May Have Been Breached

- We also regularly track the Dark Web to see if your information has been compromised.
- When this happens, we immediately notify you and your wealth manager.
